6 CLLS Finance Law Committee secured transaction reform discussion paper: fixed and floating charges on insolvency

The contents of the discussion paper were noted by the Committee and it was recognised that differentiating between fixed and floating charges creates issues for finance lawyers in structuring and documenting security. The Committee considered that, from an insolvency perspective, the statutory discrimination against floating charges largely reflected policy considerations which did not interfere with the operation of insolvency proceedings as such but that it was important that floating charge assets were available to be used by administrators.

7 Cape Town Convention

The Chairman briefed the Committee on the proposals to introduce rules akin to the US on powers of enforcement in relation to aircraft of insolvent airlines following the intended ratification by the UK of the Cape Town Convention. Adrian Cohen and Dominic McCahill will attend the Insolvency Service stakeholder meeting on Wednesday 26 March.
