Jennifer Marshall noted the ILA/CLLS/R3 and FMLC had met with the Insolvency Service to discuss further the merits of amending the administration expenses rules in light of recent case law. A draft is expected to be circulated to stakeholders for review by the end of November setting out the criteria for what should be an expense and introducing wording to get rid of the current artificial distinction between paragraph 99 and Rule 2.67.
