#### 10 Any other business

It was noted by the Committee that the Regulation amending the EU Insolvency Regulation was due to be adopted without vote by the European Parliament. The amendments were debated by the European Parliament on 19th May with the final act being signed on 20th May. It is awaiting publication in the Official Journal, but it does not appear that further amendments were made since the version published by the Council on 26 February 2015. It was also noted that it was expected that further harmonisation would be pursued following the Commission recommendation on a new approach to business failure and insolvency.
