Judicial Opportunities in the Tax Chamber Virtual Seminar 29th March

A selection exercise will be launched in Spring 2023 aiming to recruit four salaried Judges of the First-tier Tribunal (Tax Chamber) and two salaried Judges of the Upper Tribunal (Tax and Chancery Chamber). For the First-tier Tribunal roles, candidates with a background in tax and a minimum of 5 years legal experience post-qualification. For the Upper Tribunal roles, candidates with a background in tax and/or financial services with a minimum of 7 years legal experience post-qualification.

The seminar aims to help individuals prepare their applications and offers up-to-date guidance and advice on the Judicial Appointment Commission (JAC)'s selection process. You will hear from Judge Greg Sinfield, President of the First-tier Tribunal (Tax Chamber), Mrs Justice Bacon, President of the Upper Tribunal (Tax and Chancery), together with salaried judges from those tribunals, Judge Kim Sukul and Upper Tribunal Judge Swami Raghavan. There will also be a representative from the JAC in attendance.
